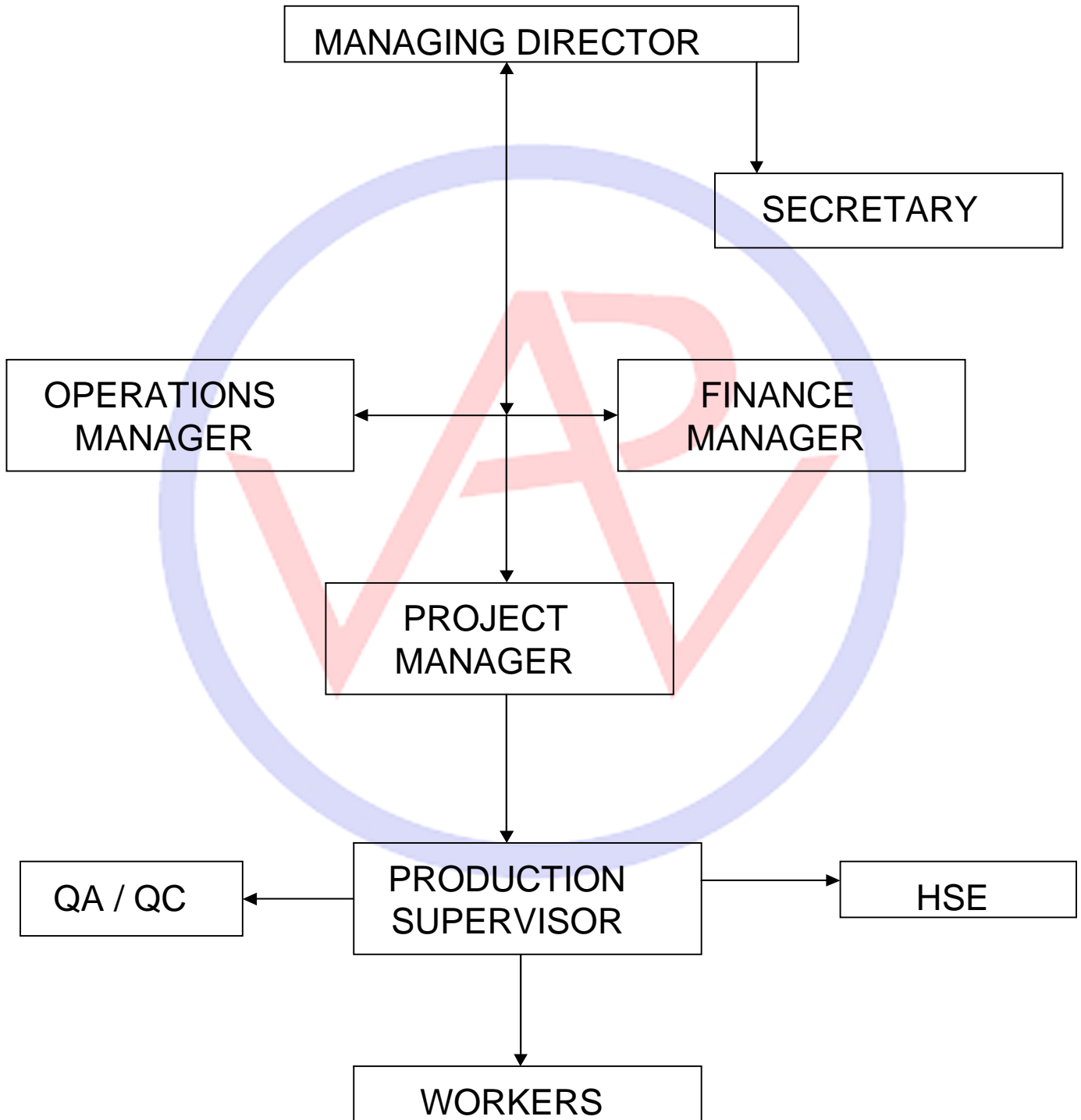

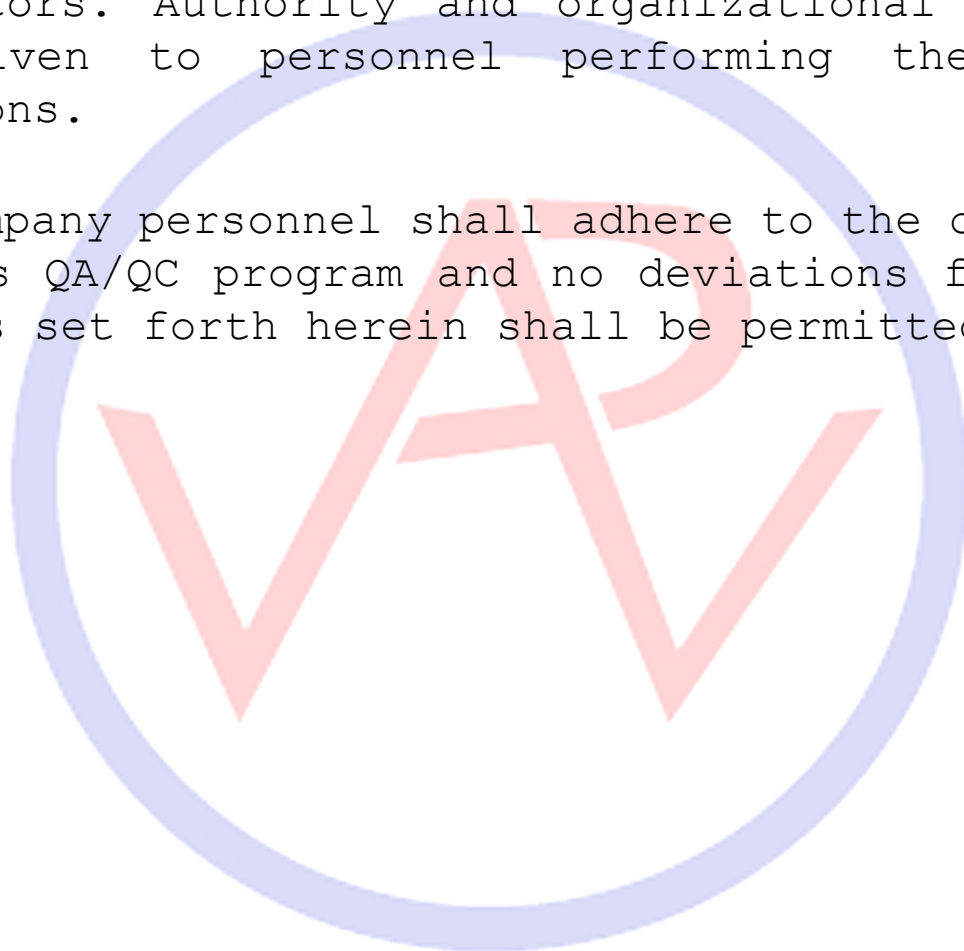

HSE POLICY

□ **The main purpose of the policy is to,**

- A. Increase personal safety,
- B. Systematically monitor the working environment in order to reduce damage to health,
- C. Systematic treatment of lost of time and near miss accident to prevent recurrence,
- D. Reduce the accident frequency with in the work site.

□ **SAFE Practice Of Work**

Prior to any operator starting work he will be made fully aware of all risk involved in carrying out the operation and how to minimize the associated hazards. In order to manage the control of hazards and risks it is essential to follows some fundamental principles.

- A. If possible, avoid the risk completely, by using different materials or methods if they are not essential to the activity.
- B. Wherever possible, adapt work to individual, especially in choice of workplace, equipment and methods of working with the aim of reducing monotony that contributes to potential hazards.
- C. Take advantages of technological progress that often makes work safer and more efficient.
- D. An active and safety culture must exist and be assured so that the principle of risk prevention are part of everyone's attitude at every level in every activity.
- E. Incorporate preventive measures in a coherent policy to progressively reduce or eliminate risks.
